THE SUNSHINE DIVISION OFFERS FOOD AND CLOTHING ASSISTANCE FOR FREE SIX DAYS A WEEK AT THEIR NORTH THOMPSON FACILITY AND FIVE DAYS A WEEK AT THEIR SE STARK FACILITY WHICH OPENED NOVEMBER 2017. ADDITIONALLY, EMERGENCY RELIEF IS PROVIDED 24 HOURS A DAY THROUGH THEIR PARTNERSHIP WITH THE PORTLAND POLICE BUREAU WHO STORE FOOD BOXES AT EACH POLICE PRECINCT THAT CAN BE DISPATCHED TO THOSE IN NEED AT ANY TIME. IN DECEMBER 2018, 3,800 HEARTY HOLIDAY FOOD BOXES WERE BUILT AND STORED IN THE SUNSHINE DIVISION WAREHOUSE. 2,500 HOLIDAY BOXES WERE PERSONALLY DELIVERED TO PORTLAND HOMES (WHO SIGNED UP VIA SUNSHINE IN NOVEMBER) BY VOLUNTEERS, AND 1,300 HOLIDAY BOXES WERE DISTRIBUTED TO LOCAL SCHOOLS, CHURCHES, AND SOCIAL SERVICE ORGANIZATIONS TO HELP FAMILIES IN THE METRO AREA DURING THE HOLIDAY SEASON.
